ACCESSIBILITY AND DISABILITY PLAN

Introduction

The Children's House School is committed to inclusion and is a place where children of all races, religions disabilities, gender, abilities and social circumstances will find security and respect for themselves, their families, other people and their traditions.

The Children's House is a nursery and infant school on two sites. The Nursery is in a listed building that was previously a Hindu Temple. The only access to the two classrooms is via stairs. Unfortunately, it is not possible to install a lift.

The infant school has level access to all classrooms and a purpose-made ramp for access to the Church hall.

Aim

Schools are required under the Equality Act 2010 to have an accessibility plan. The purpose of the plan is to:

- Increase the extent to which disabled pupils can participate in the Curriculum
- Improve the physical environment of the school to enable disabled pupils to take better advantage of education, benefits, facilities and services provided

Our school's aim is to treat all its pupils fairly and with respect. This involves providing access and opportunities for all pupils without discrimination of any kind.

The Children's House is also committed to ensuring staff are trained in equality issues with reference to the Equality Act 2010, including understanding disability issues.

The School's complaints procedure covers the accessibility plan. Concerns relating to accessibility in the school or nursery are set out in this procedure. This document meets the requirements of schedule 10 of the Equality Act 2010 and the Department of Education (DFE) guidance for schools on the Equality Act 2010.

Schools are required to make 'reasonable adjustments' for pupils with disabilities under the Equality Act 2010.

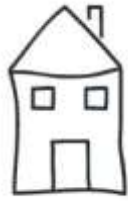
